Regional vision:

Ocean conditions are changing, new uses of the sea are emerging, and the authorities for ocean management are complex and overlapping. These West Coast-wide challenges are best evaluated holistically rather than as individual management entities.

History of the WCOA Regional Ocean Partnership

- 2007 West Coast Governors Agreement on Ocean Health was established
- 2010: President Obama executive order enabled formation of Regional Planning Bodies for federal engagement in ocean policy
- 2013-2016: Formation of West Coast Regional Planning Body for ocean policy (west coast states and federally recognized tribes)
- 2016: West Coast Governors Agreement on Ocean Health morphed into West Coast Ocean Partnership, coastal resilience, changing ocean conditions, and data coordination with emphasis on engaging tribal governments
- 2018: President Trump signed an executive that terminated Regional Planning Bodies but allowed coordination to continue via Regional Ocean Partnerships
- December 2018: West Coast Regional Planning Body and West Coast Ocean Partnership combined to form the West Coast Ocean Alliance
- 2022: NOFOs announced to fund ROPs and tribes wishing to engage with them
 - Our grant was funded AND the WCOA received funding

Ocean Health Dashboard (upcoming, will include salmon module)




Our grant's objectives
